

Guidelines *Tijdschrift voor Sociale en Economische Geschiedenis*

General

Version: 22 June 2009.

Articles have to be submitted per email to **Huub Sanders**, hsa@iisg.nl

On the cover page please write: author's name, full address (including zip code, phone number, email address) and academic title.

On the first page of the article please indicate the number of words.

Articles should be no longer than 8.000 words (including references).

All articles should be originals, should not have been published previously and are not to be submitted elsewhere at the same time.

Authors have to provide a short biography which includes year of birth, place of work and current position, major or recent publications, and (again) full address.

The author provides an English summary of 75 to 125 words, plus a title.

Tables, graphs, and maps should be numbered, should have a clear title, should be simple and should be delivered as separate files. In the text please indicate where tables, graphs and maps should come:

Maps in TIF or JPEG, graphs in Excel.

Per article we like to publish two illustrations. The illustrations should be free of rights. Please provide originals (no photo copies) or JPEG and TIF (300dpi). If costs are involved please contact Huub Sanders before ordering.

In the text please indicate where illustrations should come:

Paragraph breaks should be indicated by *indents* and not *line breaks*. The first paragraph of an article, and of sections, should not be indented.

Articles should be divided into sections marked by short titles. Do not number sections, and avoid sub-paragraphing.

Quotations: follow the punctuation, capitalisation and spelling of the original. For short quotations use single quotation marks. Long quotations of fifty words or more should be typed as a displayed extract, i.e. a separate block with a space above and below without quotation marks.

For quotations within quotations use double quotation marks. For ellipsis in quotations use three full points in square brackets: [...].
Punctuation follows closing quotation marks except where whole sentences are quoted.

Quotes in languages other than Dutch or English should be translated in footnotes.

Articles should be in British English (not American English). Please use -ise rather than -ize (and -sation rather than -zation).

Do not use abbreviations. Provide an explanation for any acronym at the first mention:

General Agreement on Tariffs and Trade (GATT)

Dates should be typed as follows: 5 July 1985.

In referring to a century write, for instance, nineteenth century (not 19th century). Note that when used as an adjective a hyphen appears between the ordinal and the word "century": nineteenth-century labour.

Figures and Numerals: units of measurement and all numbers over 20 should be given in figures; others should be in words (e.g. ten workers) except in passages with enumerations (8, 17 and 43 percent).

Write 30 percent not 30%.

Foreign words and phrases should be italicised

References

An unnumbered initial note – a superscript asterisk at the end of the title – can be used for acknowledgements (of the assistance of colleagues and of grants from foundations).

TSEG uses the reference system which is common among historians: references are in footnotes, which are numbered throughout.

Reference follows punctuation: .²³ (not ²³.)

Books

One author:

Two authors:

Philip Armstrong, Andrew Glyn and John Harrison, *Capitalism since world war II. The making and breakup of the great boom* (London 1984) 320.

More than three authors:

Erik Buyst c.s., *De Bank, de frank en de euro. Anderhalve eeuw Nationale Bank van België* (Tielt 2005) 19-21.

Please note that capitalisation is not used in English titles.

If several titles are listed in one footnote please separate them by a semi column (;).
When referring to pages use full page numbers: 214-221 (not 214-21).

When a title is mentioned for the second time, use short titles:

Atkinson, *Knowledge and explanation*, 56.

Mitterauer and Sieder, *Vom Patriarchat zur Partnerschaft*, 23-27.

Quotations in titles get double quotation marks:

Please note that references to articles include first the full range of pages followed by a reference to the specific page you are referring to.

If a journal is referred to more than once the title may be abbreviated:

Reference to archives

First mention the archive in which the material is kept (with the abbreviation of the name of the archive in brackets), followed by the name of the archival source, number in the inventory, title of the archival piece, plus page numbers (if available):

Gemeente Archief Tilburg (further GAT), Secretarie Archief 1810-1907 (further SA), inv. nr. 29, Notulen van de openbare vergadering van de gemeenteraad Tilburg, 3 June 1884.

Or

Municipal Archive Tilburg (MAT), Archive of the secretary (AS), inv. No. 29, Minutes public meeting city council Tilburg, 3 June 1884.

Or:
